A BYLAW OF THE CITY OF BROOKS, IN THE PROVINCE OF ALBERTA TO AUTHORIZE VOLUNTARY PAYMENTS OF SPECIFIED PENALTIES FOR BYLAWS 76/215, 82/490, 84/546, 85/555, 91/08, 91/36, 92/04, 93/14, 94/20, 94/33, 96/17, 97/25, 99/13, 01/34, 02/36, 02/41, 03/25, 04/07, 05/02, 06/05, 06/22, 07/08, 09/12, 09/18, 09/26, 10/20, 11/04, 12/03, 12/04, 12/05, 12/06, 12/08.

WHEREAS, Section 44 of the Provincial Offences Procedure Act RSA 2000, c.P-34 authorizes a municipality to prescribe specified penalties in respect of offenses committed under municipal bylaws;

AND WHEREAS, the Council of the City of Brooks deems it expedient to allow for the voluntary payment of a specified penalty on various bylaws;

NOW THEREFORE, the Council of the City of Brooks in the Province of Alberta hereby enacts as follows:

TITLE:

1. This Bylaw may be referred to as the "Specified Penalty" Bylaw.

GENERAL:

2. Summons Violation Tickets may be issued and voluntary payments may be made pursuant to Part 2 of the Provincial Offences Procedure Act R.S.A. 2000 c. P-34 and the amendments thereto in respect of an alleged contravention of a provision of Bylaw No's.: 76/215, 82/490, 84/546, 85/555, 91/08, 91/36, 92/04, 93/14, 94/20, 94/33, 96/17, 97/25, 99/13, 01/34, 02/36, 02/41, 03/25, 04/07, 05/02, 06/05, 06/22, 07/08, 09/12, 09/18, 09/26, 10/20, 11/04, 12/03, 12/04, 12/05, 12/06, 12/08 and any amendments thereto.
3. If a summons or offence notice under Part 2 or Part 3 of the Provincial Offences Procedure Act R.S.A. 2000 c. P-34 is issued in respect of an alleged contravention of a provision of Bylaw No's.: 76/215, 82/490, 84/546, 85/555, 91/08, 91/36, 92/04, 93/14, 94/20, 94/33, 96/17, 97/25, 99/13, 01/34, 02/36, 02/41, 03/25, 04/07, 05/02, 06/05, 06/22, 07/08, 09/12, 09/18, 09/26, 10/20, 11/04, 12/03, 12/04, 12/05, 12/06, 12/08 and any amendments thereto, the specified penalty payable upon conviction in a court of competent jurisdiction shall be:

SEVERABILITY:

- 4. It is the intention of Council that each separate provision of this Bylaw shall be deemed independent of all other provisions herein and it is the further intention of Council that if any provision of this Bylaw is declared invalid, all other provisions herein shall remain valid and enforceable.

REPEAL OF BYLAW

- 5. That Bylaw No. 00/05 and amendments thereto be hereby repealed


EFFECTIVE DATE
