BYLAW NO. 25/29**

**A BYLAW OF THE CITY OF BROOKS IN THE PROVINCE OF ALBERTA TO  
AMEND BYLAW 23/08 BEING A BYLAW TO ESTABLISH UTILITY RATES  
CHARGED TO CUSTOMERS.**

**WHEREAS**, it is desirable to amend Bylaw 23/08 being the Utility Rates Bylaw;


**NOW, THEREFORE** the Council of the City of Brooks in the Province of Alberta hereby enacts as follows:

1. That Schedule "A" of Bylaw No. 23/08 be deleted in its entirety and replaced with the attached Schedule "A".
2. That Schedule "B" of Bylaw No. 23/08 be deleted in its entirety and replaced with the attached Schedule "B".
3. That Schedule "C" of Bylaw No. 23/08 be deleted in its entirety and replaced with the attached Schedule "C".
4. That Bylaw 25/04 be hereby repealed.
5. That this Bylaw take effect upon final passing thereof.

Read a first time this 10<sup>th</sup> day of December, 2025.

Read a second time this 15<sup>th</sup> day of December, 2025.

Read a third time and finally passed this 15<sup>th</sup> day of December, 2025.

**SCHEDULE "A"**  
**BYLAW NO. 25/29**

1. Effective **January 1<sup>st</sup>, 2026** every Customer connected to the City's Sanitary Sewage System shall be charged bi-monthly rates in accordance with this Schedule.
  - a) Each Residential Dwelling Unit: base rate of \$46.83 per unit.
  - b) Each Business Premises connected to the City's Water Distribution System and Sanitary Sewer System: base rate of \$46.83 plus \$1.08 per cubic meter or portion thereof of water consumption in excess of 41 cubic meters per billing period.
  - c) Each Business utilizing the Sanitary Sewage Truck Disposal Facility shall be charged a flat rate of \$1,924 per year, plus \$1.08 for each cubic meter of Sanitary Sewage discharged.
  - d) Customers outside the City Boundaries will require a separate agreement with the City and may be charged additional fees based on that agreement.

**SCHEDULE "B"**  
**BYLAW NO. 25/29**

1. For Water Services that have been disconnected due to non-payment, non-compliance or any other reason, a disconnect/reconnect fee of \$55.00 shall be paid by the Customer prior to the Water Services being reconnected.
2. Effective **January 1<sup>st</sup>, 2026** every Customer connected to the City's Water Distribution System shall be charged bi-monthly rates in accordance with this Schedule.
  - a) Residential  
Each Residential Dwelling Unit: base rate of \$69.64 for the first 13.65 cubic meters or less, plus an additional charge of \$1.56 per cubic meter consumed in excess of the first 13.65 cubic meters per dwelling.
  - b) Businesses  
Each Business Premises: base rate of \$69.64 for the first 13.65 cubic meters or less, plus an additional charge of \$1.56 per cubic meter consumed in excess of the first 13.65 cubic meters per Premises. The number of base rate(s) charged is dependent on the number of Water Meter(s) installed on the Premises, unless one Business utilizes more than one meter.
  - c) Food Processing Industries  
First 13.65 cubic meters or less - \$69.64 base rate. Over 13.65 cubic meters up to and including 3,409 cubic meters, an additional \$1.56 per cubic meter. Over 3,409 cubic meters, an additional \$0.65 per cubic meter.
  - d) Bulk Water - City Owned (Residential/Domestic)  
\$4.88 per cubic meter
  - e) Bulk Water - City Owned (Non-Residential/Commercial Business)  
\$6.51 per cubic meter
  - f) Bulk Water - Privately Owned Stand Pipes  
\$2.16 per cubic meter with a minimum charge of \$34.65 per month
  - g) Raw Water Rate - Eastern Irrigation Fish Rearing Facility  
\$69.64 for the first 13.65 cubic meters of consumption plus \$0.65 per cubic meter consumed in excess of the first 13.65 cubic meters

## **SCHEDULE "C"** **BYLAW 25/29**

Effective **January 1<sup>st</sup>, 2026** every Customer of the City's Waste Management System shall be charged bi-monthly rates in accordance with this Schedule.

### **Garbage Collection:**

#### **Residential Dwelling Units:**

1. The waste management charge for collecting waste once each week from a Residential Dwelling Unit shall be \$32.26 bi-monthly.
2. In the event that a Residential Dwelling Unit utilizes more than one bin, a charge of \$32.26 bi-monthly will be applied for each additional bin.
3. In the event that no waste collection service is provided, the minimum charge shall be \$32.26 bi-monthly.
4. The reduced waste management charge for a Customer who is at least the age of 65 years shall be \$22.21 bi-monthly.
5. The waste management charge for collecting yard waste from a Residential Dwelling Unit shall be \$0.

#### **Residential Dwelling Units from Which a Home Occupation is Operated:**

1. The waste management charge for collecting waste once each week from a residential dwelling from which a home occupation is operated shall be \$37.45 bi-monthly.
2. In the event that no waste collection service is provided, the minimum charge shall be \$37.45 bi-monthly.
3. The reduced waste management charge for a Customer who is at least the age of 65 years and who operates a home occupation from their residence shall be \$27.38 bi-monthly.
4. The waste management charge for collecting yard waste from a Residential Dwelling Unit from which a home occupation is operated shall be \$0.

#### **Businesses:**

1. The base rate for Waste Management Services shall be \$46.04 bi-monthly, per Business.
2. The waste management collection charge for each garbage tip shall be \$20.23.
3. In the event that no waste collection service is provided, the minimum charge shall be equal to the bi-monthly base rate.
4. In the event that a commercial Premises is vacant, a base rate will not apply. It will be the Owner's responsibility to notify the City of any vacancies.

**Recyclable Cardboard:**

**Businesses:**

1. The waste management charge for each cardboard tip shall be \$30.30.

**Recycling:**

1. The recycling fee charged to every Residential Dwelling Unit or Residential Dwelling Unit from which a home occupation is operated shall be \$9.70 bi-monthly.
2. The recycling fee charged to every Owner of a Business shall be \$9.70 bi-monthly. In the event there are multiple Businesses, the charge shall be \$9.70 bi-monthly per Business.
3. In the event that a commercial Premises is vacant, a base rate will not apply. It will be the Owner's responsibility to notify the City of any vacancies.
